### Terms & Conditions

#### A. Technical

1. The material put for e-auction shall be disposed off in "AS IS WHERE IS" basis. 2. Those willing to examine the material./Goods will carry original Aadhaar Card & PAN card and will deposit entry fee of Rs. 500=00 (Non-refundable).
3. Entry for bidders will be from **Gate no. 4** of Training School, U P Police Radio Headquarters, Lucknow between 1100 to 1200 hrs and 1500 to 1600 hrs.
4. Successful Auction Purchaser will have to collect items of LOT-1 from **Various Districts/Units of Uttar Pradesh** (As per Appendix-A).

#### B. Taxes:

#### C. Payment Terms:

1. On completion of bid and issue of "Acceptance H1 Bid value by the department" the bidder shall deposit to Govt. 25% of the amount, by Demand Draft of bid value with in 05 (Five) days (from the date of display of letter of AOC on website) to the IGP/Director, Radio Communication, UP Lkw. Successful Auction Purchaser will remit the balance 75% amount by Demand draft of highest bid within a period of 15 (Fifteen) days from the date of display of letter of AOC on Website. The bidder should ensure that he pay the balance due in time and lift the material with in stipulated period, thereafter. If successful

- auction purchaser fails to deposit initial 25% amount his EMD will be forfeited and further he will be disqualified for participation in further e-auction of Uttar Pradesh Police Radio Headquarter, Lucknow.
2. The successful Auction purchaser must pay the balance 75% of the bid value within 15 (Fifteen) days from the date of display of letter of AOC on website in form of Demand Draft (In name of IGP/Director, Radio Communication, UP Lkw) deposit within prescribed time limit in Uttar Pradesh Police Radio Headquarter, Mahanagar, Lucknow. In case of Failure to pay the balance 75% amount within the stipulated time period, an interest of 18 % will be charged (to be calculated on the daily basis) on the balance amount till maximum 30 (Thirty) days. If further failure to pay the amount within extended 45 days, the 25% amount along with EMD specified above will stand forfeited & the AOC will be treated as cancelled.
