विषयः भारतीय दण्ड संहिता की धारा 376(3), 376AB, 376DA तथा 376DB के सम्बन्ध में आपराधिक विधि संशोधन अधिनियम 2018 द्वारा अंतःस्थापित धारा 439(1)(क) के अनुपालन विषयक।

प्रिय महोदय,

आप अवगत होंगे कि आपराधिक विधि संशोधन अधिनियम 2018 द्वारा भारतीय दण्ड़ सहिता, भारतीय साक्ष्य अधिनियम तथा दण्ड़ प्रक्रिया संहिता में व्यापक संशोधन किये गये हैं, इसी कम में दण्ड प्रक्रिया संहिता 1973 की धारा 439 की उपधारा (1) में पहले परंतुक के पण्चात निम्नलिखित परंतुक अंत स्थापित किया गया है —

परतु यह और कि लच्च न्यादालय या सेशन न्यादालय किसी ऐसे व्यक्ति हो नो भारतीय दंड संहिता को धारा 376 की उपधारा (3) या धारा 376कर या धारा 376धक या धारा 376धक के अधीन विचारणीय किसी अपराध का अभियुक्त है, जमानत लेने के पूर्व जमानत के आवेदन की सूचना, ऐसे आवेदन की सूचना की प्राप्ति की तारीख से पन्द्रह दिन की अवधि के भीतर लोक अभियोजक को देगा।"

Troyided further that the High Court or the Court of Session shall, before granting bail to a person who is accused of an offence triable under subsection (3) of section 376 or section 376AB or section 376DA or section 376DB of the Indian Penal Code, give notice of the application for bail to the Public Prosecutor within a period of fifteen days from the date of receipt of the notice of such application.";

में जमानत प्रार्थन नहीं पर सुनवाई के पूर्व 15 दिवस का नोटिस दिया जाना आज्ञापक हो गया है। इसी प्रकार प्रारं 439(1A) जोड़े जाने के बाद घारा 376(3), 376AB, 376DA तथा 376DB में जमानत प्रार्थना पत्रों पर सुनवाई के समय वादी मुकदगा अथवा उसके द्वारा अधिकृत किसी व्यक्ति की उपस्थित सुनिश्चित किया जाना अनिवार्य कर दिया गया है, जिससे पीड़ित पक्ष को जमानत स्तर पर सुनवाई में उपस्थित रहने का अधिकार प्राप्त हो गया है।

- 3. प्रथम सूचना दर्ज करते समय तथा विवेचना के दौरान तैयार किये जाने वाले प्रपन्नों/आरोप पन्न में उपर्युक्त अपराध की धाराओं एवं उपधाराओं का विशिष्ट रूप से उल्लेख न किये जाने के कारण मा0 सन्न न्यायालयों तथा मा0 उच्च न्यायालय द्वारा द0प्र0सं0 की धारा 439 के संशोधित प्राविधानों को लागू करने में किठनाईयाँ आ रही हैं।
- 4. अतः आप सभी को निर्देशित किया जाता है कि प्रथम सूचना अंकित करने से लेकर विवेचना पूर्ण किये जाने तक तैयार किये जाने वाले समस्त प्रपन्नों / आरोप पन्न में बलात्कार की उपर्युक्त धाराओं का विशिष्ट उल्लेख उपधाराओं सहित किया जाये, जिससे द०प्र०संठ के संशोधित प्राविधानों को लागू करने में कोई कठिनाई न हो।
- 5 उपरोक्त संशोधित प्राविधानों से अधीनस्थ सभी अधिकारी /विवेचकगण को भली भाँति क्षीप करके इसका अक्षरणः अनुपालन कराया जाना सुनिश्चत करें

## THE CRIMINAL LAW (AMENDMENT) ACT, 2018

No. 22 of 2018

[11th August, 2018.]

An Act further to amend the Indian Penal Code, Indian Evidence Act, 1872, the Code of Criminal Procedure, 1973 and the Protection of Children from Sexual Offences Act, 2012.

BE it enacted by Parliament in the Sixty-ninth Year of the Republic of India as follows:—

### CHAPTER I

#### PRELIMINARY

1, (1) This Act may be called the Criminal Law (Amendment) Act, 2018.

Short title and commencement

(2) It shall be deemed to have come into force on the 21st day of April, 2018.

Provided further that any fine imposed under this section shall be paid to the victim.
