Respected Sir,

The Institute of Constitutional and Parliamentary Studies (ICPS) is a premier research institute. It is headed by the Hon'ble Speaker, Lok Sabha who is ex-officio President of the Institute. The core activities of the Institute include imparting training, conducting capacity building programmes, workshops, seminars, etc for officers of Lok Sabha, Rajya Sabha Ministries (Centre and State), officers /officials of Embassies / High Commissions working in India and other departments/ institutions.

2. Sir, at the initiatives of the Union Ministry of Home Affairs, ICPS has been mandated to start a series of Training Programme on "Newly Enacted Criminal Laws" for officials of various Ministries (Centre and States) and Legislative Assemblies. So far Eight such programmes in this series have successfully been organised in Parliament House Complex

3. In line with the mandate and support of the Ministry of Home Affairs for the ibid training programme, the Ministry of External Affairs has also extended mandate to ICPS to conduct Training Programme on 'New Criminal Laws' for officers / officials of Embassies High Commissions working in India. The programme has been conducted twice and turned out to be a huge success with two hundred plus participants from 83 countries/missions working in India.

4. The New Criminal Laws which have come into force w.e.f. 01.07.2024 as such, there is a need to put in efforts to spread greater awareness and adaptability amongst all the stakeholders. A solid understanding of India's criminal laws to officers/ Officials of the government departments will further empower and enhance their skills,
