Taking into consideration the needs of the investigating officers for 2. training in a particular field, the eligibility criteria for undertaking a particular course has been revised and incorporated in the training calendar. You are requested to kindly see the above mentioned training calendar (July to December, 2015) and nominate officers as per eligibility criteria. Officers who do not meet the eligibility criteria will not qualify for taking up the training course at the CBI Academy. We will also not be able to send confirmation of nomination in respect of such officers.

It has also been observed that officers from State Police Organizations 3. are frequently being nominated to attend a course which is not at all related to his domain assignment currently at his hand. In this regard, it has been decided by the CBI that we may request all the State Police Chiefs that they may mandatorily send their officers for a particular domain course, which is immediate required for upgrading their professional skills. In case, the State Police Chief feels that some other domain related training is required for a particular officer, he may also nominate him but it should be optional. This scheme shall reduce the burden of nominating officers at State level and simultaneously ensure the participation of officers pertaining to their domain assignment currently at hand. However, the courses mentioned above at Sl. No.1 to 14 are opened for every willing/eligible Investigating Officer.

- 4. It is requested that the nomination of suitable/eligible officers (one Main & one Reserve) from your Organization, for the above said training courses, may kindly be sent to this Academy as per the enclosed proforma at least 45 days before the date of commencement of the particular course.
- 5. It is also requested that you <u>may kindly send consolidated</u> nomination of <u>suitable/eligible officers</u> (one <u>Main & one Reserve</u>) with their contact details (E-mail/Mobile Number) for the above said training courses to the SP (Training), CBI Academy, Ghaziabad by Fax or Email. For specialized courses, only those officers may be nominated who have minimum basic knowledge and experience of investigation of such cases and are proficient in English.
- 6. It is further requested that nominated officers may kindly be properly briefed to maintain utmost discipline during the training period at CBI Academy and also strictly to avoid Jeans, T-Shirts, Casuals, Chappals/Sandles, Mobile & other electronic gadgets. Families with participants are not allowed to stay in CBI Academy.
- 7. It is also requested to kindly relieve the nominated officers for the courses only after receiving confirmation from this academy. In case, the concerned office/branch is unable to spare the main participant, the reserve participant may be spared to attend the course in place of the main participant under intimation to this Academy.
